Of all the weapons China uses against the United States and the West, the most pernicious and effective is TikTok, he said. TikTok's parent company, ByteDance, is a Chinese company that works closely with mainland military/intelligence agencies.

The purpose of the app's algorithm is to addict Western users and target to shape their minds of young Americans. Which in order to achieve their own goal of manipulating Western society. It has penetrated into the heart of American culture and has become a central part of the lives of American children and young people.

During the 2020 riots, there were instructional videos on TikTok on how to get involved in criminal acts.

The true identity of the Chinese female mayor of Bamban City in the Philippines, Guo, and the fraud park she is involved in have recently become one of the hot topics of widespread media attention. # Selly Corpses Scandal Revealed in China's State

A Corpse trafficking case was involving Shanxi Orui, a subsidiary State Company of China National Nuclear Corporation, broke out in Shanxi, China. The company reportedly purchased at least 4,000 corpses from crematoria and hospitals across the country to manufacture bone graft materials. After the exposure, the CCP authorities have completely blocked the news.

But, the netizens linked these messages together, raising questions and lamenting whether mainland China, ruled by the CCP, has become a hell on earth.

In 2016, the African Zambian newspaper "Kachepa" published a report on its front page titled "China feeding Africa with human meat." It quoted a Zambian woman who worked and live in China, that when she was invited to an interview with a Chinese beef processing company, she discovered that the factory used human corpses to process canned beef and sell it to southern African countries. Before this report, someone also posted horrifying photos of a "human meat processing factory" on Facebook.

As early as the 1990s, there was a rumour that the Chuntu Ham Factory in Shenyang city, [North-eastern China] was "jointly operated with a funeral home." Some people said, "I have eaten hair and nails in Chuntu's ham sausage." Others said, "Chundu is very close to the funeral parlour. As a result, the sales of Chuntu ham plummeted and Chuntu was it closed down in 2010.

## Former Japan gangster cadres saw Falun Gong practitioners who have been harvested alive by the CCP

Sugawara Chao washed his hands in 2015 and is now an economic commentator with more than a dozen books on economics. He is an internet celebrity who criticizes the CCP with 220,000 followers on Twitter.

In 2007, Sugawara's friend's brother's liver disease worsened and needed an organ transplant. Through an agent a donor in China was found and ready to undergo surgery. However, before the operation, a blood product called albumin prepared by the hospital was found to be a fake and could not be used for surgery. His friend asked Sugawara to source albumin in Japan and bring it to Beijing. As a result, Sugawara was able to understand the shady scene of the CCP's live organ harvesting of Falun Gong practitioners. When I arrived In Beijing, an armed police officer came to pick me up, but the airport personnel found albumin medicine in the checked luggage, and said that medicine could not take it in China without permission, and I was detained.

The airport police, the public security police, and the armed police are not part of the same system, so they do not give in to each other and quarrel for several hours. In the end, it was through the role of politicians that they finally let me out of the airport. I handed over my medicine to the hospitals and visited my friend's brother the day before the surgery.

The doctor in charge told me that the donor was next door, and I could take a look, I saw a young man under anaesthesia who appeared unconscious. The doctor told me that the donor was a criminal sentenced to death, and he would eventually die anyway, so let him contribute something before he died. He is very healthy, and was a Falun gong practitioner. However, the operation failed and the patient died during the operation.

I saw him lying there with bandages on his hands and feet, and severed tendons in his hands and feet. The doctor said this was to prevent him from escaping. He was still alive when I went to see him, and later the donor died after the organ was removed, as it was a living donor transplant.

The reporter asked many questions:

Do doctors know that there is a problem with the origin of these organs? Of course they know, but they deliberately avoid the issue because the interests of doctors and patients are aligned. **Does the General Hospital of the Armed Police Force actively carry out organ transplant surgery?** Yes. According to them, wealthy people from Europe, the United States, Russia, Saudi Arabia and other Middle Eastern countries will come for surgery. I saw some Europeans and Americans. Japanese were the only ones with my friends at the time, but I heard that many Japanese came for surgery. Patients have a special waiting area, which I guess is at a nearby hotel. They are frequently examined by the hospital.

**Are** CCP officials are also involved? Absolutely. They said that without the participation of CCP officials, it would be impossible to carry out organ transplants, and many things could not be handled. At the China's airport, we used special exits, passages and secret underground tunnels reserved for high-ranking officials, and I didn't see any other vehicles. At that time, in addition to the high-ranking officials who came to pick me up, there were also four armed policemen with guns. From the airport to Beijing, it was the car of the armed police that opened the way for us. When the senior officer came to pick me up at the airport, the car drove directly under the plane, then the customs officer went under the plane to stamp my entry passport, after the car drove out from the place where it said "VIP Entrance".

Do the major media in Japan know about this? They know, but they don't report it, because, they still want to continue doing business in China. At that time, reporters from a major Japan media were also there, and they wanted to report the news about the organ transplant, but of course the hospital refused. When I was having dinner with the intermediary's people, the reporter was there. The Chinese doctors, they don't think they're doing anything wrong, they think they're dealing with death row prisoners. Are they all being brainwashed or do they know....?



## A 99-year-old Former SS Secretary, was Convicted

Germany's Supreme Court August 20, rejected the final appeal of the former SS female secretary upholding the guilty verdict two years ago. This was the first trial of a civilian employee of a Nazi concentration camp. The outcome made it clear that there is joint liability, for being part of the killing machine, and you cannot escape.

Irmgard Furchner, now 99, lives in a nursing home in Schleswig-Holstein, Germany, she has to face the guilt of her 18-year-old crimes.

It was between 1943 and 1945. Fouchner was working as a typist in the Stutthof concentration camp near Danzig. Located in northern Poland, the first Nazi concentration camp to be established outside the borders of Germany. An estimated 65,000 people were murdered in the Stutthof camp, including Jews, Poland partisans, and Soviet prisoners of war.

In December 2022, the Itzehoe District Court in Germany sentenced Fouchner to two years in prison on 10,505 counts of conspiracy and five counts of attempted murder.

Fushner's lawyer appealed the verdict, he argued that Fuchner did not really realize that she was part of a "killing machine" and believed she was just doing "normal secretarial work." There is no conclusive evidence or documents that Fushner was an accomplice in the murders.

The federal judge found that Fouchner was aware of what was happening at the concentration camp. She saw parts of the workplace, the chimneys of the crematorium, and knew the miserable situation of the prisoners. As the secretary to the top commander Paul Werner Hoppe, she knew from the very beginning that the camp's officials and executors were committing crimes. Through Fushner's loyal service, she showed solidarity with them, so that her actions were no longer neutral.

Igor Wolodarski, president of the Schleswig-Holstein Jewish Community, said: "It is important that her charges are confirmed. This is an important signal to society as a whole, and to each of us, that everyone must be held accountable.

A lawyer for the co-plaintiffs in the case said the verdict showed that using a typewriter (in the "killing machine") could also be guilty.

Since Fushner was between 18 and 19 years old at the time of the crime, she was sentenced to a juvenile sentence.

## More Countries to make Protection Law of the Human Right

The Migration Amendment (Overseas Organ Transplant Disclosure and Other Measures) Bill 2023 was first introduced by Liberal Senator Dean Smith in June 2023. After much debating the bill was passed gaining support from Liberal, National, Green, and independent senators.

In the process of the bill being passed, the story of Falun Gong practitioner Mr. Cheng Peiming was widely reported by major media outlets in England, the U.S., and Australia. Mr. Cheng is the first victim found to have survived the Chinese Communist Party's (CCP) systematic live organ harvesting. Last month he went to Washington D.C. to give a speech and recount his experience of what happened to him in China. And are shocked about it. ”

## **Falun Dafa Association: Australia Parliament Targets CCP's Crimes**

Dr. Lucy Zhao, President of Falun Dafa Association in Australia, welcomed the new bill. She said the passing of the bill carries a special and important message, as this is the first legislative action taken by the Australia Parliament to curb illegal organ harvesting. During the debate, the senators brought the attention of live organ harvesting and the CCP's persecution of Falun Gong and prisoners of conscience to the Congressional level.

Many countries passed similar bills, and Dr. Zhao hopes that the Australian government can go one step further and pass bills to punish offenders of illegal organ transplants, similar to what the U.K. and Canada have passed.
