# Experts say The CCP uses the Belt and Road Initiative to export its activities

In Canadian parliamentarians on June 14, several scholars, experts had a meeting. They calling the leaders those take part of the G7 summit meeting in Canada on this month 16, 17, 2 days, to speak out and take action to help stop the CCP's live organ harvesting in China.

Dr. Andreas Weber, a deputy director of the European department of the Doctors Anti-Live Organ Harvesting (DAFOH), said, "Live organ harvesting is clearly undermining and completely subverting the 'altruistic organ donation system' that we have established around the world. There is a system in the United States, in the European Union and other countries, and the organ transplant system is based on ethical medicine.

I know a woman, we all have information about her- including her blood type, her name, which city she come from and other details. Unfortunately she is an alcoholic and therefore cannot get on the waiting list for an organ of the European Organ Transplant Network. As a result, she went to China three time, each time with extremely short waiting and had three times liver transplants, spending about \$400,00 US dollars. You can imagine what happened over there — in China.... Said: Dr Weber.

According to Dr Weber said, he started working in Europe on organ transplantation before 2006. At that time, we often faced the problem of how long the organs could be preserved, when we were finding a matching organ was a joy in itself. To carry out a large-scale transplant – at that time, it was impossible to think about.

Of course, some people wonder if there is any way to increase the number of organ donors, but we never thought of such a thing as 'killing people to get organs. So, this "organ harvesting" is an extremely abominable thing, and we must make it clear to the doctors, the medical profession, the seriousness and horror of this act, especially from the perspective of the victims, to arouse people's empathy and vigilance.

### Through the Belt and Road Initiative

Dr Webb said governments and the international community need to speak out and take action to stop the CCP's misdeeds, it risks their own medical systems being corrupted. If we take this crime led by the [CCP] state – organ harvesting – lightly to oppose it, or we don't stop it, then our country own medical system may also be corrupted. He said:

actually, this corrosion has already begun – through the Belt and Road Initiative.

On, May 10, 2025, the International Investigation Report on the Development Model of the Belt and Road Initiative of the Communist Party China in 2013 was traced.

The CCP has gradually incorporated the organ transplant industry into the Belt and Road Initiative to establish International Organ Transplantation Cooperation and Development Alliances to export organ transplant technology, train doctors, and to establish a platform for cooperative hospitals in countries along the Belt and Road, aiming at Europe, Asia, and Africa since in 2016.

The reported said; alliance was established in 2019 at the 4th China-International Organ Donation Conference in Kunming –Yunnan province, in Southwest China, where representatives from 62 countries reached a consensus. According to the report, the inclusion of organ transplantation in the Belt and Road Initiative framework is essentially exporting the CCP's live organ harvesting model to the international, and it more seriously it is promoting organ trafficking and other criminal activities in other countries.

## Dr. Webb: The CCP may have started exporting the organ preservation technology to the outside world very early years ago.

When I was involved in organ transplantation in 2015, my organ procurement team used a small kidney-saving device. "It's the size of an eggshell, a little bigger like a rugby ball, and it can be used to preserve the kidneys for a longer time." He said he had also seen Chinese surgeons perform liver transplants with the same device in some studies. If we don't scrutinize this practice at the international level and bring in truly independent medical and human rights experts to monitor China's organ transplant practices, then I am afraid that

through the Belt and Road Initiative, this unethical medical practice will be 'exported' to our country, Dr Weber said.

#### He said that the CCP cannot be trusted.

This is true of the CCP when doing business with us or with the G7 countries. They are always using all kinds of numbers, abilities, and data to 'mislead' us. For example, the relationship between the CCP and Iran — we don't really know how much money is flowing between these two countries. On the surface, it may be a rare earth trade or something, but in fact it could also be an arms trade or something. So it all looks like a vague hoax, a fog. Look at the G7 countries and the Belt and Road Initiative and how the CCP is closing its own market and not opening up the European market. The mechanism behind this is actually the same as what it does in the medical field."

## The Communist Party believes that, if they ignored the Falun Gong, then the China Communist Party will disappear. Matas said.

Lawyer Matas also said at the conference, "To a certain extent, I think the Belt and Road Initiative actually is a tool of transnational oppression and for foreign interference. The CCP persecutes its own non-governmental organization (NGO) community and people at home, at the same time carries out transnational repression against NGOs and individuals overseas, basically, they use all external contacts – including foreign trade, donations, aid, and so on, to counter any voice that is critical of them, to achieve their goals.

An estimated 1.5 million organ transplants have been performed in China in the past 15 years, the source of most came From Falun Gong people, he said.

### Former Military Doctor Revealed New Babies Become Supply Part of a State - Owned Organ in Mainland China

Zheng Zhi, a former Chinese military doctor, came to Taiwan on June 4 to 15. This year is the 36th anniversary of the Tiananmen Square massacre on June, 4, 1989. He attended the screening of the "State - Owned Organs" the Supervisory Commission of the Human Rights Committee in Taiwan, and he visited other cities to show further screenings to audiences.

The film focused on two Chinese families' search for their missing relatives of 20 years. The "State-Owned Organs" exposes the CCP's systematic persecution of Falun Gong practitioners and live organ harvesting since 1999 through witness testimony and real-life cases, involving mass incarcerated, torture, to killing-on-demand to supply the organ transplant market. The film has won numerous international awards.

"At the screening of "State-Owned Organs" in central Taiwan, a nurse revealed that he had heard many times that patients were going to China for kidney replacement, and some doctors had even seen the presence of children's kidneys in patients during ultrasound examinations, which made people question the source of the organs." Zheng Zhi, who worked as a paediatrician at Liaoyang 153 Hospital

(now the 8th People's Hospital of Qingyang Hospital), responded that similar incidents have been going on in mainland China for a number of years.

Zheng Zhi, That he knew about the liver necrosis of a Northeast official, the doctor used a large syringe to extract liver tissue fluid from a new born baby after sterilizing the syringe then directly injecting the tissue fluid into the liver of a CCP official, because modern medical equipment is very accurate, the baby's liver tissue fluid was quickly activated in his body. The official's lived for about ten years."

The CCP was very cruel in extracting liver tissue fluid from new born baby because the baby died after the operation. In fact the baby is still alive, the death certificates has been prepared in advance, so this was "killing on demand". The crimes against humanity committed by the Communist Party by taking advantage of the development of medical technology have completely violated human morality. The most basic conscience of human beings.

Regarding the CCP's "killing on demand", Zheng Zhi pointed out that if you are in good health, or any organ has good quality, including eyeballs, "As long as one day your blood type is matched, you don't need to offend anyone, you don't need to hurt anyone, no matter what job are you do or what education you have, you may face a dangerous situation in China." You may disappear one day, and your family will not be able to find you."

Zheng Zhi said that there are many doctors and nurses in China have been brainwashed by the Communist Party culture, as long as there is a need to "kill people on demand", you can't refuse in that environment, and if you refuse, you will lose your job. China has turned doctors and nurses into a profession of medical killers.

He said: that the CCP carried out massacres under the banner of the state and political party, it's completely a criminal group, and the evil is

beyond the imagination of all countries and mankind. He appeals to the world to promote a legislative action of Law on Combating and Preventing Live Organ Harvesting, and hoping to use his lifetime to curb the CCP's national violence of "killing people on demand".

July 5th is the 16th anniversary of the 2009 Massacre. Omer Kanat, executive director of the Uyghur Human Rights Project (UHRP), said "Sixteen years ago, the killing and enforced disappearance of innocent Uyghur protesters paved the way for the genocide in East Turkestan today."

The international community has a responsibility to pressure the Chinese government to end its arbitrary detention and enforced disappearances of Uyghurs and to release all those currently detained. At that time the, Xinjiang university students staged a peaceful demonstration in Urumqi, demanding that the government handle the matter. The CCP sent armed police to crack down, where at least 197 people were killed and another 1,721 injured.

Following this, the CCP used this as an excuse to implement mass surveillance and a harsh policy of forced assimilation. It has demanded that Muslim residents not wear halal burgas and men not to wear beards, and has set up controversial "re-education camps" where thousands of Uyghurs have been forced to learn Chinese, remove their religious beliefs, and those who resist may be subjected to corporal punishment and torture.

According to the international human rights organization End Transplant Abuse in China (ETAC), Xinjiang, with a population of 26 million, currently has three hospitals and medical centres that can perform organ transplants, and the CCP plans to build six more in Xinjiang by 2030, four of which are located in the capital Urumqi.

Wendy Rogers, chair of ETAC's advisory board, said Uyghurs, who are mostly non-drinkers, are considered an "ideal" source of organs. Falun Gong practitioners, who also do not smoke or drink alcohol and have a healthy lifestyle, were the main victims of live organ harvesting at the earliest, and then the Uyghurs were also subjected to mass persecution.

#### **Annual Petition to G7+7**

Forced organ harvesting has been described as a slow, concealed cold genocide against Falun Gong because it is used for profit and to eliminate the group and its practice of truthfulness, compassion and tolerance. Insufficient action by the international community has allowed these crimes to continue and be perpetrated against the Uyghur population and well in recent years.

The unethical or criminal medical practices of one country threaten the ethical standards of medicine worldwide. A direct, decisive response from the international community is urgently required to stop this barbaric crime.
